

**2012 Open International Free Pistol, Standard Pistol and Air Pistol
Sectional Championships

Dates: March 17-18, 2012

Rules: Current NRA International Pistol Rules will govern. Scoring will be off-line.

Distances: Free and Standard Pistol – 50 feet

Air Pistol – 10 meters

Pistols: Free Pistol – Rule 3.6

Standard Pistol – Rule 3.5

Air Pistol – Rule 3.7

An equipment check will be conducted at registration. All equipment must meet NRA rules.

Targets: Free Pistol – B-11 (5 shots per target)

Standard Pistol – B-33

Air Pistol – B-40/1 (1 shot per target)

Eligibility: NRA membership is encouraged, but not required. A foreign competitor is eligible to participate in the sectionals, however only U.S. citizens may win the First, Second and Third place National Individual and Team Championship awards.

Teams will consist of three (3) firing members (Rule 2.11(A), (B), a Regular Service Unit, National Guard or Reserves (Rule 2.13) or a State Association (Rule 2.12).

Classification: Each competitor will be classified according to the NRA International Classification System in individual and team matches and must be prepared to exhibit a current International Classification Card or Score Record Book upon registration. Unclassified competitors will fire in the Master class (Rule 19.6). Teams will be classified per Rule 19.12.

Challenges: A challenge fee of \$1.00 will be charged for each challenge made. Ties will be broken according to Rule 15.

Team Entries: Team members must be designated before any team member fires the individual match. The individual match scores will be used for the team score total. The team match is not a fired match.

Squadding: All matches will be squadded. Preference will be given to early entries and those entering all three matches. If air pistol entries exceed range capacity, the excess entries will be allowed to infiltrate as squadded entries complete the course of fire.

Entries: Entries are limited to 15 per day in the Free and Standard Pistol matches. Air Pistol entries in excess of 15 per day will be allowed to infiltrate as stated above. Post entries will be accepted up to range capacity provided such entries will not require extra relays.

Matches: Match #1 – Free Pistol (60 shots)

Match #2 – Standard Pistol (60 shots)

Match #3 – Air Pistol (60 shots for all shooters)

Match #4 – Free Pistol Team Match

Match #5 – Standard Pistol Team Match

Match #6 – Air Pistol Team Match

Matches #1, #2 and #3 are fired matches

Individual Fees: \$8.00 NRA registration fee plus \$11.00 fee per fired match. \$46.00 package fee if competitor fires all three matches. Make checks payable to Binghamton Rifle Club.

Team Fees: \$8.00 NRA registration fee per team for each team match.

Schedule of Firing: The same schedule will be fired both days.

Match #1 – start 9:00am

Match #2 – start 11:15am

Lunch – 12:30pm to 1:30pm

Match #3 – start 1:30pm

Sectional Awards: Class awards will be provided for Master, Expert, Sharpshooter and Marksman classes. All awards, yet to be determined, will be provided by the NRA as follows:

Fired Matches #1, #2 and #3:

Open Winner: Gold Tone Sectional Medallion + 15 Award Points

Open Second Place: Silver Tone Sectional Medallion + 10 Award Points provided there are at least ten competitors.

Open Third Place: Bronze Tone Sectional Medallion + 5 Award Points provided there are at least fifteen competitors.

Class First: 9 NRA Award Points provided there are at least five competitors in a class.

Class Second: 7 NRA Award Points provided there are at least ten competitors in a class.

Class Third: 5 NRA Award Points provided there are at least fifteen competitors in a class.

Open Award winners are not eligible for Class Awards. If there are fewer than five competitors in a class, that class will be combined with the next higher class. If there are not enough competitors in a class after combining classes, that combined class will be combined with the next higher class. If there are fewer than five competitors in the master class, those competitors will compete for open awards only. Competitors will be eligible for awards only in the categories entered

National Open Championship awards will be provided directly from the NRA for High Senior, High Grand Senior, High Woman, High Junior Woman and High Junior.

Team Matches #4, #5 and #6:

Open Winning Team: 15 NRA Award Points, 5 points to each team member, provided there are two or more teams for that match.

Directions: The range is located on NY Route 7 (Conklin Road) about 100 meters south of the Binghamton City Line. When approaching from the North take Interstate 81 and use Exit 2; from the South take Interstate 81 and use Exit 2W. Proceed about 1 mile from Exit 2 (1.4 miles from Exit 2W) and turn right just past the tall overhead bridge at the Route 7 South sign. Take the next right and follow Route 7 South signs to Route 7 (“T” intersection and red light) Turn left on Route 7 North. The range is about 1.5 miles up Route 7 on the right side of the road, the second building past Cottman Transmissions, sitting back from the road.

When approaching from the East, use Route 17 Exit 75 and proceed about 1.5 miles to the tall overhead bridge and follow directions above.

When approaching from the West, use NY Route 17 to Interstate 81 South to Exit 2, and then follow the same directions above.
