**Rules:** Current NRA BB Gun Rules will govern. Scoring will be off-line.

**Distance:** 5 Meters

**Authorized Guns:** Official guns for the Daisy National BB Gun Championship Matches are the Jaycee Target Special Model 299, Daisy Special Model 99, and the Avanti Champion Model 499 and 499B. No other guns are approved or permitted. However, for this match only, we will allow guns that meet the requirements of the NRA BB Gun Rules.

An equipment check will be conducted at registration. All equipment must meet NRA rules.

**Targets:** NRA AR 4/10

**Eligibility:** Must be a New York State resident, between the ages of 8 and 15 and meets rule 2.3.

**Challenges:** A challenge fee of \$1.00 will be charged for each challenge made. Ties will be broken according to Rule 15.3

**Team Entries:** Team members need not be designated before any team member fires the individual match. The top 5 individual match scores will be used for the team score total. The team match is not a fired match.

**Squadding:** All squadding will be done at the range. Each team will be assigned a lane for the entire match. Depending on the number of entries, extra lanes may be assigned to facilitate a shorter match. The match will be shot in the same format as the National Match. ie...all shooters will shoot prone before moving on to standing, and so forth.

**Entries:** Entries are limited to 13 teams, and **must be received by March 10, 2012.**

**Individual Fees:** \$10.00 Make checks payable to Binghamton Rifle Club.

**Team Fees:** \$5.00 per team.

**Schedule of Firing:** The prone match will begin at 10:00 am.  
Standing will begin at the conclusion of the Prone match.  
Sitting will begin at the conclusion of the Standing.  
Kneeling will begin at the conclusion of the Sitting match.  
There will be no written test in this year's Match.

**Awards:** Awards will be provided for the top 3 teams, top 3 shooters, and the top 3 shooters in each position.

**Directions:** The range is located on NY Route 7 (Conklin Road) about 100 meters south of the Binghamton City Line. When approaching from the North take Interstate 81 and use Exit 2; from the South take Interstate 81 and use Exit 2W. Proceed about 1 mile from Exit 2 (1.4 miles from Exit 2W) and turn right just past the tall overhead bridge at the Route 7 South sign. Take the next right and follow Route 7 South signs to Route 7 ("T" intersection and red light) Turn left on Route 7 North. The range is about 1.5 miles up Route 7 on the right side of the road, the second building past Cottman Transmissions, sitting back from the road. When approaching from the East, use Route 17 Exit 75 and proceed about 1.5 miles to the tall overhead bridge and follow directions above. When approaching from the West, use NY Route 17 to Interstate 81 South to Exit 2, and then follow the same directions above.

**Food:** Restaurants are located in the area.
